# A Message from the President:

Hello, La Casa Owners.

2012 has been another good year for La Casa. There have been a number of changes during the year and many are noted elsewhere in the newsletter. Perhaps most significant for all owners are two noteworthy projects of your board of directors. First, your board has begun very preliminary discussions to develop a comprehensive makeover plan for the resort. Early discussions center around upgrades to all units on a predetermined and ongoing schedule. While the resort continues to be in solid structural condition, it is beginning to show age in the individual units. Although we are early in the process, your board will keep you informed as decisions are made.

Second, the board and office staff is working to update ownership records and recover deeded weeks from non-paying owners. On November 6, approximately 50 units were recovered through foreclose and are now available to be transferred to new owners. Since La Casa is a non-profit corporation, these weeks cannot be sold for profit. The deeded weeks are being made available to current owners first and then to others for the payment of the annual maintenance fee and an additional \$125 transfer fee. Information on available weeks can be obtained from the reservations office upon request.

Accurate ownership deed records are critical to an organization such as La Casa. If you have had a change in any ownership information, please contact the reservation office and help us to correct and maintain our ownership records.

# 2012 YEAR IN REVIEW

# February, 2012 Annual Meeting/Election of Board and Officers:

The Meeting was held at the Comfort Inn on Padre Island and was called to Order by President Lindy Roberts at 1:00 PM. The 2011 Annual Meeting minutes were read approved. Treasurer Dennis York discussed the financials for 2011 and answered any questions. He emphasized the importance of legally transferring timeshare deeds to a spouse or children, to avoid confusion in the future. Ann Rolan has been and will continue to update the Owners list to avoid confusion in the future. Last year Dennis appealed our Tax Assessment but while the Appraisal District did not accept them we were successful in having the original Assessment lowered for the next two years. He also presented the report from our CPA and offered to share it with anyone interested. All deeds showing Unit 101 (Resort Office) as their home units were updated to other units with the Owners consent to avoid any confusion. The Association has transferred over 60 units to new dues paying members. Mikel Bilano our Resort Manager reviewed the work being done to keep the property up to LCDS standards. All the mattresses have been replaced and the stairway Towers facades have been repaired and repainted.

Nominees for Board positions were introduced, and while ballots were being counted, Steve Trubatisky presented an overview of the plans for the Schlitterbahn Water Park on Padre Island. Ben Harbour was elected to his first term while Dennis York and Jerry Lamel were reelected to serve their second and final term. Each was elected to a 3 year term with Ben replacing Sue Cigainero whose term had expired.

PLEASE NOTE: All Board members are unpaid, elected volunteers, and this is a *working* Board. Effective management of the resort and business operations, on behalf of all owners of La Casa del Sol, requires the dedication of many hours of independent effort by each Board Member. Board meetings are held about every six weeks in the Fort Worth area, with the exception of the February meeting, which is held in conjunction with the Annual Owners' Meeting, and that alternates between the DFW area and North Padre Island.

#### La Casa del Sol Staff

Ann Rolan has stepped down as our full-time Reservations & Accounting Office Manager in Weatherford. She will continue on a part time basis continuing her efforts to update all deed records and identify those which should be considered for foreclosure. Heather Vantrease who was working part time in the office was promoted to Office Manager. This leaves the part time position open. We will be looking to hire an individual as soon as possible. The Reservation Office has been directed by the Board to apply the reservation rules equitably to all owners, with favoritism to none. Please refer to the website (www.lacasareort.com) for recent clarification of the rules regarding reservation of Deeded Weeks, Interval Plus (IP) Weeks, and Owner Bonus time. These are not new rules, simply a clarification of those which some have found confusing in the past. If there are still questions please call either Heather or ask to have a Board member call you back for clarification. If you are unable to reserve the accommodations you desire, please remember that the Reservations Office is directed to follow the Rules and Regulations voted upon by the Board of Directors, so please avoid asking for any special considerations. Remember that except for Service Animals, no pets are allowed on the Resort Property at any time.
